How to Recertify Your Laminated Products

- 1. Test fee is \$500.00 (U.S.) per lot, pass or fail.

 Typical lead time is five (5) business days after receipt of material. Place an order with Parker Chomerics for part number 97-TEC-RE-CERT.
- 2. Send the following for each material lot to be evaluated for recertification:
 - Strips: 3 feet total of material needed, consisting of three each of 1 foot strips
 - Sheet stock: 8" x 8" sample (recertification cannot be performed on cut parts)
 - Roll goods: 1 foot long by roll width. For rolls smaller than 3" width, please send three samples, each sample to be one (1) foot long by roll width.

3. Send material to be recertified to:

- **4.** Upon passing results, a recertification letter will be provided with the new product shelf life extension. Shelf life is extended from the original expiration date. If material fails, you will be notified and no recertification letter will be sent.
- **5.** Material sent for recertification testing will not be returned and will be retained for quality control purposes.
